### **JOB SUMMARY**

First Tee – Greater Richmond (FTGR) is a youth development organization that uses the game of golf and its inherent values to shape the lives of young people from all walks of life. We are strengthening the character of the community by providing programs that build resilience in our youth, teach critical life skills, and provide caring adult supervision in a safe environment. In December 2020, The Tattersall Youth Development Center underwent a \$700,000 renovation that included repurposing the interior of the clubhouse for better functionality, a new Trackman 4 simulator, added space for youth programs, and improved patio space for parents and golf outings.

The primary purpose of the outside staff is to provide optimal service to all patrons, members, First Tee participants, or other guests. In order to fulfill these duties, the outside staff member may be asked to do, but not limited to, the following: washing/sanitizing carts, picking the driving range, marshaling on course, and starting play on the first tee box.

Outside staff teammates are expected to work flexible hours and often on weekends and some holidays.

## **Key Responsibilities:**

- Sanitizing and washing all high-touch areas on golf carts and driving range equipment
- Staging carts in front of golf shop
- Picking the driving range and maintaining cleanliness of all practice facilities
- Marshalling the course and ensuring proper pace of play
- Making sure all course rules are being followed by patrons
- Reporting any issues, questions, and/or concerns to Professional Golf staff
- Providing a high level of customer service to all patrons, members, First Tee participants, and
- other guests
- Other duties as assigned
